Holloway, Jr. American Inn of Court. Tom also served as a speaker at the Oklahoma Association of Defense Annual Trial School (2006, 2007) and received the Oklahoma Association of Defense Counsel Distinguished Service Award (2006). He also previously served as the President/Managing Partner for the Firm.

Tom co-authored An Overview of Oklahoma Product Liability Law, 86 OKLA B. J. 830 (2015), Kirkland v. General Motors Corporation and Beyond: An Overview of Twenty Years of Oklahoma Product Liability Law, 65 OKLA. B.J. 3593 (1994) and, An Overview of Oklahoma Product Liability Law, 73 OKLA. B.J. 2231 (2002), the latter of which won the Oklahoma Bar Journal "Golden Quill Award."
