- **\$30 Million Jury Tort Verdict:** After 3-week trial, won jury verdict with \$30 million in punitive damages for tortious interference and competition claims for Continental against Fortune 500 company. Defended verdict over appeals, collecting well over \$11 million (with \$10 million more in companion case) and setting new tort standards
- Nationwide Impact in Insurance Law: Won 10th Circuit appeal, reversed \$17 million verdict, and made new law enabling nationwide insurance company to depreciate labor on actual cash value and replacement cost claims with nationwide impact on interpretation of insurance policies.
