Biography

Kathryn has also defended several municipalities, officers, government agencies and contractors against due process and property rights claims. Kathryn also represents municipalities during internal grievances and administrative disputes related to employment decisions and collective bargaining (Union) contracts. Working closely with local municipalities, she offers training to their public safety departments, as well as other employees, on a range of issues related to discrimination, labor, use of force and constitutional rights, including due process and 4th Amendment protections.

Her practice includes a substantial amount of fast-paced crisis management, when matters break quickly and media and/or law enforcement are involved. These matters can be on a variety of subjects ranging from active shooters, public safety emergencies,
